202 Loan Activity

Growth Capital certainly continued teaming up and winning big for small business with its loan activity. This year, we had sixty one (61) total loans approvals and maintained the Number One SBA 504 and Community Advantage Lender in all the Midwest. While SBA 504 lending in the district increased considerably last year, we were able to scramble throughout 2021 and actually increase our market share to more 21% in the entire state of Ohio with total project financing of \$82.8MM.

Growth Capital had yet another "Record Year" with more gross dollar investment in our nearly forty (40) years of operations with more than \$37.6 million in approved loans which leveraged over \$100 million in economic development investment in our communities during 2021. Our participation has adding significantly to the overall economic activity of our region with the potential to add over 550 new jobs for Ohio workers. Loan closing production for fiscal year 2021 funded through September 30, 2021 with loan closing dollar volume reaching \$14.1MM.

Additionally, after having funded over \$16.7MM in PPP loans in Round 1 during 2020, providing vital payroll and employment funds to some 291 struggling small businesses through our innovative partnership with Fifth Third Bank. In 2021 Growth Capital teamed up with a national Loan Service Provider for Round 2 PPP funding of more than \$13.7MM to about 192 small businesses right here in Ohio. Our total PPP Mission Impact fully realized in 2021 was over \$30MM for approximately 483 borrowers. Now that's undoubtedly "Teaming Up + Winning BIG" for Small Business.
